- 1. Call to Order 3:11pm, Kurt Meyer
- 2. Introduction of Guests (5 minutes)
 - a) Ray Chandos, Irvine Valley College (IDEA)

- 3. Adoption of Agenda (2 minutes)
 - a) Motion made by Don B., seconded by Lewis L.;
 - b) Unanimous approved.
- 4. Approval of Minutes –May 7, 2018 (3 minutes)
 - a) Motion made by Ari G., seconded by Susan B.;
 - b) Unanimously approved abstention from Melanie H. (not present at last meeting)
- 5. Introduction of New Faculty Association Administrative Assistant Madeline "Maddie" Hernandez (2 minutes)
 - a) Maddie briefly said hello and introduced herself.
- 6. Introduction of Grievance Co-Chairs/Grievance Panel Saddleback: Margot Lovett, Claire Cesareo [new]; Irvine Valley: Kathy Schmeidler, Dan DeRoulet [new] (5 minutes)
 - a) Margot was present and has served as grievance chair for 5-years. Kurt thanked all of the grievance chairs for their service.
- 7. Introduction of New Rep Council Members (5 minutes)
 - a) All new and returning representatives introduced themselves.
- 8. Rep. Council Member Orientation and Introduction of "Rep's Reports" Kurt Meyer (15 minutes)
 - a) Definition of Representative Council from the SOCCCDFA Bylaws and Standing Rules (pgs. 6-9). Kurt asked what you have done as a representative (see pg. 8 of 33, #5: Faculty representatives shall do the following.....)
 - 1. Frank G. every day I would read one page of the faculty contract. You serve as an expert on all things contract related. Created a board in the breakroom to post workshops, newsletter, fliers and other relevant information.
 - 2. Jenny L. I ask if anyone has questions. Provide meeting notes/minutes. Bring any questions from faculty to the larger group.
 - 3. Christina G. as chair I am in constant contact with our PTs. I try to inform them of FA, send membership forms.
 - 4. Don B. during division meetings, I make sure faculty know the benefits of membership.
 - 5. Margot L. although the meeting minutes are posted, I send them out with a special asterisk so faculty know it's an important email
 - 6. Ardith L. when important items come up in our division meetings, I ask if they want me to bring it to the Rep Council.
 - b) Rep's Reports: Kurt wanted to start having representatives share reports from their divisions/departments.

- 1. Margot L. I suggest we not have reps report at set times, instead when items/issues come up.
- 9. Membership Report Jenny Langrell (10 minutes)
 - a) Jenny suggested we read the dissent by Keagan. We have had very few (2-3 people) faculty request withdrawal from the union. I was happily surprised. Please go to people individually and ask them if they would like to join. The non-members may not know of the benefits or what they are missing out on.
 - b) Frank the existing faculty are not much of an issue, but new faculty must opt into membership. We should not just reach out with an email, but in person.
 - c) Kurt Maddie, myself and another faculty member stuffed over 700 envelopes and placed them in PT faculty mailboxes.
- 10. Part-Time Committee Report Beth Clary (5 minutes)
 - a) Continuing the membership discussion. Handout on representative council, specifically the section on PT faculty. PT representatives on Rep Council are based on the number of PT members. It is wonderful to have more PTs who want to be involved.
 - b) In your packets you have two (2) fliers. First workshop is on retirement and is scheduled on September 21st, specifically geared towards PTs. Maddie will email an electronic version of the flier to Rep Council members. Second flier is fall 2018 important dates for PTs.
- 11. Communications Committee Report Parisa Soltani (5 minutes)

- 12. Treasurer's Report Frank Gonzalez (5 minutes)
 - a) Green handout on SOCCCDFA Proposed Budget. Our general dues income will be down, Frank had to estimate the loss of 'fees' income.

 - 1. Motion made to approve proposed budget by Lewis L., seconded by Ardith L.;
 - 2. Unanimous approved.
- 13. Organizing Committee Report Lewis Long (5 minutes)
 - a) Lewis: meeting with VCHR and she asked if we are planning any faculty demonstrations. The BoT get frustrated with the demonstrations and it's best we don't take any action. We can continue to meet before BoT meetings. Kurt is a great organizer and I will take his lead on

this. If we do need to organize, an email will go out and your responsibility is to reach out and recruit faculty to attend a BoT meeting.

- 14. Negotiations Report Lewis Long (10 minutes)
 - a) General positive direction. Negotiating team of the District is getting more comfortable.
 Most of their members are new to negotiations at the District and just new to the District overall.
- 15. Political Action Committee Report Kurt Meyer (10 minutes)
 - a) PAC meeting over the summer and voted to support and endorse TJ P. (Area 2), Marcia M. (Area 3), and Terry W. (Area 4). They are generally faculty friendly and supported the CANVAS conversion. No one is running against Marcia or Terry, but someone is running against TJ in Area 2. CTA makes a mailer for elections and our candidates' names will be on said flier.
 - b) Motion made to approve the endorsement the PAC made of the 3 candidates for BoT made by Melanie H., seconded by Ari G.;
 - c) Unanimous approved.
 - d) Question: how much would this cost? Those Areas (3 & 4) with no one running against the incumbent, cost a few hundred dollars. Area 2 (TJ) may have to cover anywhere from \$8,000 to \$10,000. Frank we have the money and we will be applying for an ABC Grant from CTA. In the past, we have received the costs we have asked for from CTA. We expect to recoup all the costs.

 - 1. Ray Chandos has volunteered for IDEA.
