1) Call to Order

The meeting was called to order at 3:09 p.m.

2) Introduction of Guests

Jack Beckham, Department Chair for English at Saddleback College was introduced as a guest. Fawn Tanriverdi is a guest and is running for representative for the School of Guidance and Counseling at Irvine Valley College.

3) Adoption of Agenda

Moved by Don Bowman; seconded by Jenny Langrell; unanimously approved.

4) Approval of Minutes

a. September 14, 2015

Moved to approve with edits by Martha Stuffler; seconded by Mike Hoggatt; unanimously approved.

5) Negotiations Report – Lewis Long (50 minutes)

Lewis Long stated that the purpose is to present the proposed contract for approval from the Representative Council prior to sending to the membership to ratify. On 10/15/2015 there will be a general meeting to discuss the proposed contract with the membership. Then there will be a five day voting period for approval prior to it going to the Board for approval.

Claire Cesareo stated that we need a simple majority of those who vote to have the contract approved and that we need 2/3 vote for the bylaws approval.

- 7) Political Action Committee Report (10 minutes)
 - a. Board of Trustee Election 2016
 - b. PAC Contributions

Barbara (Bobbi) Jay and Terry Whitt seats will be up for election. There will be five seats up for election. We need to work on the PAC account contributions, voluntary deductions.

- c. Faculty Mobilization Claire Cesareo stated that we need to get people mobilized to work on the campaign (fundraisers, phone banking, precinct walking) and begin speaking with faculty now. Mark Blethen stated that there are other issues to deal with such as district elections rather than area elections, the DRAC model, and Basic Aid issues.
- 8) Organizing Committee Report Mark Blethen (5 minutes)

 Mark Blethen stated that in spring 2016 there will be an election for officers of the

 Executive Committee. It was stated that there are department chair issues that need to
 be considered.
- 9) Communications Committee Report Allison Camelot (5 minutes)

The newsletter usually goes out in November in the fall semester. The committee is going to start working on the newsletter this month. Margot suggested a special issue on the contract. Lewis stated that the election of officers in the spring is an important issue as well.

10) Membership Report – Loma Hopkins (5 minutes)

Loma was absent from the meeting. The membership reports were distributed. Allison Camelot stated that each representative was given a membership report for their division or school and representatives need to make corrections on the report and give the information to Christina or Loma as soon as possible.

- 11) Treasurer's Report Ken Woodward (5 minutes)

 Ken Woodward stated that we received a \$2000 membership bonus from CCA and approximately \$1500 refund from membership from CTA. Ken stated that expenses are as projected; expenses were discussed. Samantha Venable stated that Lewis Long did a lot of work as chief negotiator and that additional compensation is needed for him.
- 12) Part-Time Committee Report Beth Clary (5 minutes)

 Last month at the Faculty Association Orientation for new faculty there were 45 attendees which resulted in 11 new members. This month Kurt Meyer is going to moderate a workshop on "How to Apply for a Full-Time Faculty Position". Beth asked that representatives post the information in their schools/divisions. Kurt stated that there is a diverse panel presenting at the workshop. This workshop is focused on applying for a position. In the spring semester there may be a workshop on interviewing for a position.
